TAGB ELECTIONS 2026-2027

Instructions

According to the revised Bylaws approved on October 30, 2022, elections will be held for four positions of Executive Committee (President Elect, Secretary, Treasurer, and Cultural Secretary) for one-year term **2026-2027**, and three positions of Board of Trustees for a two-year term **2026-2028**.

According to the amendment to Bylaws approved on November 8, 2014, the current president-elect is required to submit the nomination form to become President in subsequent year. Nominees for the President-Elect position must have served at least two terms on the Governing Body including minimum one term in the Executive Committee.

A nominee (a person who is running for the office) for any of the four open positions must be a Life or Patron Member of TAGB and a resident of the TAGB Area. For more details on the eligibility requirements, please refer Bylaws at www.tagb.org. All nominations must be sent by USPS Certified-Mail or any trackable courier services like UPS or FedEx (and received by November 30, 2025) to the following address:

Part 2: Must be filled in by **two** nominators (not from the same household). Nominators must write the full name and the member ID legibly.

Part 3: Must be filled in by the nominee and provide his/her signature and contact information.

Part 4: A *non-refundable* nomination fee of **\$150** (payable to TAGB) must be attached for Executive Committee position and a fee of **\$300** for any position in Board of Trustees (BOT) in the form of a personal or bank check.

All nominations must be received by the Election Committee at the above address by **November 30, 2025**

The nominee is encouraged to provide a personal statement and describe his motivation for seeking the office of any of the open positions. Also, please attach a separate sheet of biodata that highlights candidate's experience and leadership skills suitable for running a Telugu cultural organization, and email soft copy of the same biodata to elections@tagb.org. The statement and biodata will be distributed to eligible TAGB voters along with election ballots, for their consideration in their voting decision. Final nominees may obtain the voter list from elections@tagb.org after signing an appropriate consent form.
